Mr. Leamon brought his concerns regarding transportation of dangerous goods through school zones. He stated that there are numerous hazardous trucks going through the school zone which could be dangerous in the event of an accident. He has spoken to the Minister of Transportation in regards to this issue and responded as follows:  
Regarding the movement of dangerous goods by road in communities, the provincial Dangerous Goods Transportation and Handling Act has a provision allowing municipalities to make bylaws, with approval by the Minister, with respect to highways under its direction, control and management for the movement of dangerous goods. This provision could

allow a municipality to designate an alternate route for dangerous goods. The Town of Lamont will investigate the impact it could have on future development within the town, should an alternate route be designated. Mayor Skinner thanked Mr. Leamon for attending the meeting and bringing his concerns forward.
