## TOWN OF LAMONT

## BYLAW 11/09

A BYLAW OF THE TOWN OF LAMONT, IN THE PROVINCE OF ALBERTA, TO REGULATE AND CONTROL THE OPERATION OF SNOW VEHICLES WITHIN THE CORPORATE LIMITS OF THE TOWN OF LAMONT.

WHEREAS, it is deemed to be in the public interest to control and regulate the use of snow vehicles within the corporate limits of the Town of Lamont, and

WHEREAS, authority is granted to municipalities under the Municipal Government Act, the Highway Traffic Act and the Off Highway Vehicle Act and Regulations, to regulate and control the operation of snow vehicles;

NOW THEREFORE, THE COUNCIL OF THE TOWN OF LAMONT, DULY ASSEMBLED, ENACTS AS FOLLOWS:

- 1. In this bylaw:
  - (a) "Operator" means a person who drives or is in actual physical control of the snow vehicle.
  - (b) "Snow Vehicle" means a motor vehicle designed or intended to be driven exclusively or chiefly on snow or ice or both.
  - (c) "Town" means Town of Lamont.
- 2. No person shall operate a snow vehicle in the Town:
  - (a) at a speed in excess of 20 kilometers per hour;
  - (b) other than on lanes and alleys as the most direct route in and out of Town;
  - (c) on a street or avenue in the Town except to cross a street or avenue, if necessary, and if:
    - (i) the operator stops the snow vehicle before entering onto the street or avenue to be crossed; and
    - (ii) the operator yields the right of way to all other vehicles and persons on the street or avenue, and
    - (iii) the operator crosses over the street or avenue or portion of the street or avenue to be crossed, by the most direct and shortest route of travel available to him;
  - (d) upon any parkland within the Town;
- 3. Notwithstanding Section 2(c), snow vehicles may be operated on designated routes in Town as per Schedule "A".
- 4. Every person who contravenes this By-law is guilty of an offence and liable on summary conviction:
  - (a) for a first offence, to a fine of \$250.00 and in default of payment to imprisonment for a term of not more than 30 days; and
  - (b) for a second and subsequent offence, to a fine of \$500.00 and in default of payment to imprisonment for a term of not more that 60 days.
  - 5. By-law 663/00 and amendments thereto is hereby repealed.
- 5. The Mayor and Chief Administrative Officer are hereby authorized to sign this By-law.
- 6. This By-law shall remain in effect until amended or repealed.
